

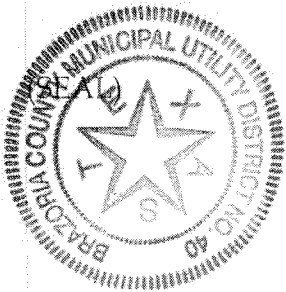
NOTICE OF MEETING

3. Financial and bookkeeping matters, payment of bills, including approve annual financial report.
4. Approve tax assessor/collector report.
5. Discuss channel and detention pond maintenance.
6. Operator's report, including:
 - a. authorize execution of First Billing Payment Services Agreement.

8. Authorize design, approve plans and specifications and authorize advertisement for bids, award contract, and approve pay estimates, change orders, and final acceptance, as appropriate for the following:
 - a. clearing and grubbing to serve Pomona Phase 4 improvements;
 - b. clearing and grubbing to serve Big Island Tracts, including approval of Cost Sharing Agreement with Brazoria County Municipal Utility District No. 39;
 - c. Lake "F" Phase 2 to Serve Pomona;
 - d. Water Supply Plant No. 1, Phase 2;
 - e. Wastewater Treatment Plant, Phase 3 to Serve Pomona;
 - f. water, sewer and drainage facilities to serve Pomona Parkway Phase 3, Pomona, Section 13, and Pomona, Section 15, and paving to serve Pomona Parkway, Phase 3, Public Portion of Pomona, Section 13, and Pomona, Section 15;
 - g. water, sewer and drainage facilities and paving to serve Pomona, Section 12, and Pomona, Section 14;
 - h. water, sewer and drainage facilities and paving to serve Pomona, Section 16; and
 - i. water, sewer and drainage facilities and paving to serve Pomona Parkway, Phase 4.
9. Approve landscape architect's report.

10. Authorize design, approve plans and specifications and authorize advertisement for bids, award contract, and approve pay estimates, change orders, and final acceptance, as appropriate for the following:
 - a. Phase 3 Landscape to serve Pomona;
 - b. Phase 4 Landscape to serve Pomona, Section 12;
 - c. Phase 4 Landscape to serve Pomona, Section 13, 14, and 15; and
 - d. Phase 4B Landscape to serve Pomona Parkway and Pomona, Section 16.
11. Deeds, easements, consents to encroachment, requests for service or utility commitment letters.
12. Receive report on development in the District.
13. Annexation of approximate 5 acres of land into the District, including:
 - a. adopt Order Adding Land and authorize execution of Amendment to Information Form; and
 - b. accept Waiver of Special Appraisal for the Benefit of Brazoria County Municipal Utility District No. 40.
